We are required to report the results of monitoring of your drinking water for specific contaminants on a regular basis by APR 2020, MAY 2019 thru AUG 2019; MAR 2019 AUG 2016; SEPT 2007 - DEC 2007. Results of regular monitoring are an indicator of whether or not your drinking water meets health standards. During APR 2020, MAY 2019 thru AUG 2019; MAR 2019 AUG 2016; SEPT 2007 - DEC 2007, we did not report the results of monitoring for total coliform.

Our system failed to notify the state drinking water program as required by APR 2020, MAY 2019 thru AUG 2019; MAR 2019 AUG 2016; SEPT 2007 - DEC 2007. Although public health was not impacted, as our customers, you have a right to know what happened and what we did to correct the situation.

**What should I do?**

There is nothing you need to do at this time. You do not need to boil your water or take other actions.

**What is being done? (Corrective action):** We collected distribution samples on 5/20/2020, 09/26/2019, 04/25/2019, 09/21/2016, and 01/01/2008 and are no longer in violation.
